School Description and Mission Statement (School Year 2010-11)

This section provides information about the school, its programs and its goals.

Abraxas High School, the continuation high school for the Poway Unified School District, takes great pride in its commitment to students and a beautiful campus that was designed and built specifically for alternative education in 1978. The school was completely renovated and modernized in 2008. Abraxas High School was designated a Model Continuation School in 1998, 2006, and again in 2010. The main campus consists of twenty-four classrooms with adjoining patios that include a career center, computer lab, art room, science lab, media center and an administration building. The buildings surround lawns and an extensive patio area with two gazebos. Portable classrooms house the Basic Education Program, the Mission to Graduate On-Line Learning Center and Quad Core. A large grassy field serves as a multipurpose soccer, softball and PE facility. Also included are handball/racquetball courts, a tennis court, basketball and volleyball courts, and a small weight lifting patio.

Our student population of approximately 300 is made up of young adults between the ages of 15 and 22, with the majority of those students residing within the Poway Unified School District boundaries. Instruction is individualized or given in small groups in learning resource classes or self-contained classroom settings. The instructional model is designed to accommodate a fluctuating student enrollment. Our curricular offerings comply with State Model Curriculum Standards and PUSD requirements for graduation, and are personalized to meet the needs of students with a wide range of skill levels, motivation and aspirations. Each student works with a homeroom teacher to develop an individualized program and to prioritize goals. Teachers help to develop student's confidence and self-esteem, as well as develop a sense of responsibility and accountability. Credits are issued as earned, with an emphasis on individual student learning and not seat time.

One of the Abraxas options is the Work Experience Program. This program emphasizes job shadowing, mentors and guest speakers, along with classroom instruction about job skills and learning how to obtain and keep a position. The program includes students who are employed full time, working 32 hours per week, and are monitored by the Work Experience Coordinator. The full-time work experience students are required to be on site, four hours each week.

Our Off-Campus Independent Study (OCIS) Program provides an educational setting for up to 10% of our students who are not able to attend school daily during regular school hours. Students are required to meet with the OCIS teacher once each week to present and review the twenty plus hours of work completed from the previous week.

The award winning Mission to Graduate program focuses on drop-out recovery and prevention. The program uses a hybrid of flexible in-class tutorial and online instruction that can be accessed anywhere. The program works closely with Poway USD Adult Education to meet the needs of older teenagers and young adults in earning a high school diploma or GED.

Affiliated with the Abraxas campus are three programs serving students with special needs. Our Special Education Transition Program has an enrollment of approximately 60 students with moderate to severe disabilities. The program is community-based and follows the Individualized Critical Skills Model that meets the needs of 18- to 22-year old adults with developmental disabilities. The Transition Program also facilitates individual development in the areas of transportation/mobility within the community, daily living skills such as budgeting, banking, cooking, and utilizing resources in the community. The emphasis is always toward maximizing an individual's potential for independence and self-sufficiency. Abraxas also has approximately 10 students in one Special Day Class and 25 students in two RSP classes. These programs offer PUSD diplomas and emphasize school-to-work transition.

Abraxas benefits from a full-time Student Services Coordinator on site. The responsibilities include coordinating our mentor program, providing student support in the areas of substance abuse, tobacco cessation and peer mediation/counseling. Abraxas is the only high school in San Diego County to have received funds through a School Community Policing Partnership Program grant. This grant incorporates career mentoring, community service and after-school activities for students referred by teachers and staff.

Our goal is to have our students connect to lifelong learning, through alternative means, in an environment that is individualized and personalized, self-paced, competency based and outcome driven.

The Poway Unified School District ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and replacing the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology.

In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

XII. Instructional Planning and Scheduling**Professional Development**

Research supports the positive effects professional development has on increasing student learning. All teaching staff is afforded the opportunity to participate in district and site sponsored professional development. These workshops are presented in a semester or year-long series and support a wide variety of professional development. These include the use of effective instructional strategies, implementing the use of computer technology in teaching and learning, critical reading, writing and mathematics strategies, effective use of assessments, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional development activities at the school, district, state, and national level. The Poway Professional Assistance Program (PPAP) provides support for new teachers. Teachers are encouraged to participate in the National Board Certification process and recognized by the Poway Unified School District when they earn NBCT status.
