School Description and Mission Statement (School Year 2010-11)

This section provides information about the school, its programs and its goals.

The Highland Ranch community takes our responsibility to our students very seriously. It is our priority to provide an academically challenging and emotionally nurturing environment for our students. The foundation for this is based on the Highland Ranch Expectations. Staff and parents are expected to teach our students respect, responsibility and safety not just through what we say, but by what we do. We focus on the whole child. Children thrive when they are in an environment where everyone is valued and respected and that is what everyone on our campus is expected to model every day.

The physical structure of our campus consists of the main campus that is built in a square, with classrooms opening onto outdoor hallways. These hallways surround an inner square structure that includes classrooms and a Learning Resource Center. As of Spring of 2004 there is also an additional two-story building equipped with an elevator. This building houses eleven classrooms and a large "common room" on each floor. There is also an outdoor court yard off the 1st floor common area.

Built in 1992, Highland Ranch is situated in a residential neighborhood in a rapidly growing suburban area of San Diego. Caramel Mountain Ranch is a planned community with shopping centers, library, and medical facilities within walking distance of the school.

Highland Ranch's student population includes 722 students in grades Kindergarten through fifth, four half day sessions of Special Education Pre-School and four classes of Autistic Special Day class students in grades Kindergarten through 5th grades.

Our special needs populations includes Autistic Special Day classes, Special Education Pre-School, Resource Special Education, , Speech and Language, the Gifted and Talented Education program and English Learners Each special needs population is served both according to state law and individual requirements.

A diverse population of ethnic groups enrich our school. There are 24 different languages represented by our 128 English Learner students. Our student attendance reporting system indicates the ethnic breakdown of our student population to be 61 Hispanic students, 60 Pacific Islander students, 57 Filipino students, 39 Chinese students, 39 Korean students, 31 African American students, 18 Japanese students, 15 Vietnamese students and 13 Middle Eastern students. 3% of our students are participating in the free and reduced lunch program.

As the diversity of our population increases it becomes increasingly important for our staff, students and parents to increase our knowledge and appreciation of different cultures and to evaluate our goals to meet the needs of our population.

Our PTA is actively involved and is very supportive of the school and our programs. In these times of increasing budget limitations our PTA as well as independent parent groups are increasingly focused on fundraising to supplement classroom budgets. Parents are encouraged and do volunteer in many capacities. Our parent workroom and classrooms are filled with parent volunteers each day. Parents serve alongside teachers and support staff on our School Site Council. Highland Ranch lives up to its reputations as an outstanding school in the Poway Unified School District and instills in the students a commitment to lifelong learning and high achievement and dedication to the development of the Six Pillars of Character and the modeling of these characteristics in staff and parents.

The staff and parent community work collaboratively to support our school mission. Together we are dedicated and committed to developing responsible life-long learners. Our vision is to provide a nurturing, challenging, learning environment that supports every child in meeting grade level standards.

Highland Ranch places strong emphasis on safety for students and staff. Emergency plans are reviewed frequently. Annual training procedures and drills for earthquakes, fire and bus evacuation are held. Maintenance staff work with a scheduled preventive program to offset costly repairs. Everyone who volunteers on our campus are required to undergo Megan's Law clearance as well as sign a district Volunteer Code of Conduct. We also require volunteers who drive students on field trips to also submit to a Megan's Law clearance. Visitors to our campus are expected to enter campus through the office, sign in and wear a badge indicating they have done so.

The school district ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and has replaced the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology. In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodian cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

XI. Instructional Planning and Scheduling

Professional Development

This section provides information on the number of days provided for professional development and continuous professional growth in the most recent three year period. Questions that may be answered include:

- What are the primary/major areas of focus for staff development and specifically how were they selected? For example, were student achievement data used to determine the need for professional development in reading instruction?
- What are the methods by which professional development is delivered (e.g., after school workshops, conference attendance, individual mentoring, etc.)?
- How are teachers supported during implementation (e.g., through in-class coaching, teacher-principal meetings, student performance data reporting, etc.)?

Research supports the positive effects professional development has on increasing student learning. All teaching staff is afforded the opportunity to participate in district and site sponsored professional development. These workshops are presented in a semester or year-long series and support a wide variety of professional development. These include the use of effective instructional strategies, implementing the use of computer technology in teaching and learning, critical reading, writing and mathematics strategies, effective use of assessments, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional development activities at the school, district, state, and national level. The Poway Professional Assistance Program (PPAP) provides support for new teachers. Teachers are encouraged to participate in the National Board Certification process and recognized by the Poway Unified School District when they earn NBCT status.
