### School Description and Mission Statement (School Year 2010-11)

This section provides information about the school, its programs and its goals.

High expectations and strong support for student learning shape the culture that defines the character of Los Peñasquitos Elementary, where student success is the only option. As evidenced in the signs that dangle from our halls, our students and staff believe every student will learn, whatever it takes. Los Peñasquitos School, in San Diego, California, is one of twenty-five elementary schools in the Poway Unified School District, and is proud to be celebrating its 35th year of enriching student lives. It is located in Rancho Peñasquitos, a community in northern San Diego County. We serve 525 students in grades kindergarten through five. Our classes include an extended-day student academy for some of our third, fourth and fifth grade classes, as well as class size reduction in our traditional K-3 classrooms. Los Peñasquitos' students represent a cross-section of our community. Forty-one percent of students receive free or reduced-price lunch, thirty-three percent of our children are English Language Learners, and thirty-five languages are spoken at our school. At the same time, a significant percentage of the children come from middle and upper-middle class families. Economic and cultural diversity are strengths and we believe that our students benefit greatly from interaction with other students who share differences with them. The majority of our parents, including parents of second language students, are active in many aspects of school life. They serve on the School Site Council, help to organize events that celebrate the many cultures represented at our school, are members of the PTA, and are very involved in our volunteer organization. Los Peñasquitos values the diversity of our students and their families, and families in turn appreciate efforts made by our school to support their children. Every decision we make is driven by our belief that all students will learn, whatever it takes. We accept no excuses for poor academic achievement, and are therefore committed to helping every child meet the high expectations represented by our district's academic standards. The community is proud not only that Los Peñasquitos' students achieve well above national averages, but also that standardized and site-developed test scores reflect continuing and significant gains in student achievement. By most measures, student performance has shown consistent and impressive improvement. Our Academic Performance Index is currently at 915. We have achieved a statewide 10-10 ranking in each of the last four years in the Accountability Performance Index. Los Peñasquitos has been recognized as a California Distinguished School and National Blue Ribbon School. Our continued growth as a professional learning community was featured in a nationally recognized book titled "Whatever it Takes" by Dr. Rick DuFour. These awards further reflect the commitment to academic excellence that is shared by our students, staff, and parents.

Each staff member has specific responsibilities during times of emergency. In addition, maintenance staff works with a scheduled preventive program to offset costly repairs. The school has an up to date Asbestos Plan. Extended Student Services is available to students for before and after school childcare.

The school district ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and replacing the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology. In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

## IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

## XI. Instructional Planning and Scheduling

### Professional Development

Research supports the positive effects professional development has on increasing student learning. All teaching staff is afforded the opportunity to participate in district and site sponsored professional development. These workshops are presented in a semester or year-long series and support a wide variety of professional development. These include the use of effective instructional strategies, implementing the use of computer technology in teaching and learning, critical reading, writing and mathematics strategies, effective use of assessments, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional development activities at the school, district, state, and national level. The Poway Professional Assistance Program (PPAP) provides support for new teachers. Teachers are encouraged to participate in the National Board Certification process and recognized by the Poway Unified School District when they earn NBCT status.
