### School Description and Mission Statement (School Year 2010-11)

This section provides information about the school, its programs and its goals.

Built in 1960, Pomerado Elementary School has served generations of Poway families. Currently our school educates approximately 500 students in kindergarten through fifth grade. We have a regular education State-funded preschool and a Parent Participation preschool serving approximately 45 three and four year olds. We also have a Level I and a Level II Autism Spectrum Disorder (ASD) preschool servicing approximately 20 special education preschool students and 9 typical peers. We also have a new Autism Support Class (ASC) with 8 special education kindergarteners. Pomerado Elementary is a Federally Funded Title 1 school.

Pomerado prides itself on dedication to academic achievement. We believe that the quality of our teachers determines the quality of our instructional program. Our staff participates in professional development activities designed around our core value of "All Students Learning." Pomerado's teaching a support staff have remained stable over many years.

We provide a wide array of academic support programs for children who require special assistance in mastering academic standards. Support programs include eight part-time reading and math impact teachers, and before and after school programs to extend the learning day for students in need of academic interventions and/or English language development. We also employ a part-time Bilingual Parent Liaison who speaks Spanish to provide translation for school documents and on-site translation services to aide in communication with teachers, staff, and parents.

A Resource Specialist Program serves approximately 30 students, and our English Language Learners program assists approximately 150 students in language acquisition and educational support. A part-time counselor (2 days per week) assists students in developing emotional health and social skills and also coordinates parenting classes. Students excelling in their mastery of grade level content in grades 3-5 are served through the Gifted and Talented Educational Program.

Pomerado cares about every child's academic and emotional development. Visit our school and you will see an atmosphere of high energy and on-task learners, caring parents and expert instructional staff.

Pomerado places strong emphasis on safety for students and staff. Emergency plans are reviewed frequently. Annual training on procedures and drills for various disasters including earthquakes, fire, lock down, and bus evacuation are held at staff meetings every August, with follow up training during staff meetings throughout the school year as needed. Students and staff participate in monthly drills as required by PUSD. Maintenance staff work with a scheduled preventive program to offset costly repairs. The school has an up-to-date Asbestos Plan. Extended Student Services is available to students for before and after school childcare.

The school district ensures that students attend clean and safe facilities.

In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

During the 2008-2009 school year Pomerado received major construction and modernization. Upgrades included the construction of a new administrative building, offices, and library media center. All classrooms received new cabling, ceiling mounts for LCD projectors, lighting, flooring, cabinetry, stackable walls, and paint. The multipurpose room and kitchen were modernized and a new covered lunch structure was built. The kindergarten and main playground were improved with new play structures and resurfacing. New landscaping will be installed throughout the campus. The entire campus is now fresh, renewed, and attractive.

## IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

## XI. Instructional Planning and Scheduling

### Professional Development

Research supports the positive effects professional development has on increasing student learning. All teaching staff is afforded the opportunity to participate in district and site sponsored professional development. These workshops are presented in a semester or year-long series and support a wide variety of professional development. These include the use of effective instructional strategies, implementing the use of computer technology in teaching and learning, critical reading, writing and mathematics strategies, effective use of assessments, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional development activities at the school, district, state, and national level. The Poway Professional Assistance Program (PPAP) provides support for new teachers. Teachers are encouraged to participate in the National Board Certification process and recognized by the Poway Unified School District when they earn NBCT status.
