School Description and Mission Statement (School Year 2010-11)

This section provides information about the school, its programs and its goals.

Rolling Hills Elementary School, built in 1978, is located in the middle of a residential neighborhood in the San Diego suburb of Rancho Peñasquitos. To the west stretches a developing canyon area. To the northwest is the 4S Ranch Community and the suburban area of Rancho Bernardo, and to the east, a major freeway corridor running North / South through the state, I-15. Single-family homes surround the school; there is a group of apartments adjacent to the south side, and a community park adjacent to the north. The Learning Resource Center (LRC) is at the center of the campus. The upper grade classrooms (3,4-5) surround the LRC and there is a 40 station computer lab adjacent to the library. Additionally 16 classrooms surround the center building housing the primary grades, preschool for three and four year old children, and Grades K to 3. In addition, the PUSD daycare for children of employees, known as the Poway Early Learning Center (PEARL Center), provides day care services for children six weeks to three years of age. This program is housed in classrooms 2, 3, and 4. There are seven portable buildings housing special programs including Literacy, Student Support Services, The Pupil Intervention Program (PIP for grades K-3), ESS and the Early Childhood Center (ECC), which is a Head Start program. The large multi-purpose room, outside lunch area, paved play areas, and grass fields cover over two acres. The school's enrollment and staffing was dramatically reduced in fall 2004 with the opening of Stone Ranch Elementary School in the district. The Rolling Hills learning community now consists of 390 K-5 students, 20 private preschool students, 14 classroom teachers, 5 Title I / EL Impact Intervention Teachers, 1 Resource Specialist Teacher, 24 support staff personnel, and one administrator. All certificated staff are highly qualified personnel with the appropriate credentials for their assigned position. Most of the students live within walking distance of the school. The homes from which the students come range from middle class to subsidized low-income apartments. We are designated as a "targeted" Title I school with 24% of our students receiving free and reduced lunch. The ethnic diversity of the school is apparent, as 27% of our students represent 18 worldwide languages and cultures. This rich cultural mix allows students to interact and learn about diversity. Some of our families are military households. Additionally Rolling Hills has experienced an increase in the population of special needs and ELL students over the past several years. We have a growing RSP program, Speech and Language services, and an Occupational Therapy program. The school enjoys the support of an active PTA, a growing school Foundation, and many volunteers in the academic setting. The PTA sponsors numerous assemblies, fieldtrips, and supplements both classroom and school budget requirements. The RHES Foundation was established in 2002 to support music, art and PE programs. Traditionally Rolling Hills has had a high rate of parent involvement, however with increasing responsibilities of the two working parent households, parent involvement is on the decline. With all of these attributes Rolling Hills maintains a high record of achievement highlighted by selection as a California Distinguished School in 1987, 1993, 1997 as well as being one of a few Title I schools to achieve superior scores on the California Standards Tests (CST), the CAT 6 and STAR. Our API (Academic Performance Index) has continued to increase and has grown to over 900 during the last four years. In the spring of 2011 our API was 935 which reflects an 11 point increase from 924 in 2010. We continue to make adequate yearly progress (AYP) with our significant student subgroups. Rolling Hills was designated as a 10 / 10 school in the California Department of Education's Similar School Ranking for several years. In the 2010-2011 school year we were designated as an "Honor Roll School" by California Business for Education Excellence. Rolling Hills was also listed as a **"Top School"** in San Diego County in an article published in the September 2007 edition of the **San Diego Magazine**. This continued growth in the school's academic performance indicates the focus on learning, increasing student involvement in goal setting and self-assessment practices, staff professional development, differentiated instruction, response to intervention (RtI), and the dedication of all stakeholders in supporting "all students learning". Rolling Hills provides family literacy education and family support through ELL and Title I family literacy events and referrals to both PUSD's Caring Connections program and outside agency support. In partnership with the PTA we plan and conduct parent education sessions focusing on a variety of topics including: health/wellness, literacy instruction, conflict resolution, media literacy, character education, and college readiness. In 2008-2009 Rolling Hills went through modernization construction, which included upgrading the technology infrastructure including additional classroom and sound system upgrades and a new HVAC system throughout the campus. As part of the school's modernization the landscape was redesigned, and Rolling Hills is the first school in PUSD with a sustainable landscape, which is a drought resistant, low water usage design. In 2007 all playgrounds were redesigned and equipment was upgraded with a rubberized surface installed under the play structures. In addition a preschool playground was constructed adjacent to the Kindergarten playground and separated by a fence. During the summer of 2006, the school's technology was upgraded with 116 new computers. The perimeter of the school grounds, surrounding fields and green space were fenced to comply with safety inspection recommendations and the Principal's request for securing the entire campus. Rolling Hills promotes and maintains strong connections with local businesses and community partners. Albertson's, Office Depot, Sony, GIA, Hewlett Packard, The Double Tree Hotel, and senior citizen groups partner with our school to support our learning community through donations, resources, and volunteer programs. In 2008-2009 our Site Council and staff revised our Mission Statement, which currently states: Rolling Hills is dedicated to reaching each student by building positive relationships, providing a rigorous and relevant education, and instilling the positive values and attitudes that are necessary for college readiness and lifelong success in a diverse and global society.

Opportunities for Parental Involvement (School Year 2010-11)

Rolling Hills recognizes the importance of the partnership between home and school and remains committed to supporting the Parents As Partners Core Value. Parents are included in the continuous improvement process and serve in an advisory capacity on committees. Parent volunteers work in a variety of capacities such as: Volunteer Workroom, Writer's Workshop, Art History, Music Appreciation, Book Fairs, Fun Run, College Field Day, Run Club, Classroom Support, School Site Council, No Excuses University/Character Counts planning team, PTA, and the Rolling Hills Foundation. In addition Title I and ELL Family Literacy activities are planned throughout the year in support of student learning and home school communications. Both the PTA and Rolling Hills Foundation sponsor family events throughout the school year, which promote parent involvement, fundraising, and family fun activities. The school newsletter, Puma Tracks, is published bi-weekly and posted on the school website, which helps to keep parents informed of current school events and opportunities for their involvement. An annual parent survey gives school staff useful feedback and information which is used to set future goals and expand opportunities for parent involvement.

Rolling Hills places strong emphasis on safety for students and staff. We are committed to ensuring a safe, orderly, and attractive learning environment by assuring the following:

- A comprehensive emergency plan and search and rescue plans are reviewed and updated at the beginning of the school year and as needed throughout the year.
- Annual staff and student training procedures and drills for earthquakes, fire, lock down, search/rescue, and bus evacuation are held.
- Annual fire inspections are conducted by our local Fire Department.
- Maintenance staff consistently inspect school grounds, play equipment, and buildings which ensures a safe environment and prevents costly repairs.
- The Connect-ED system is used by the principal to contact all families by phone and email and will be a valuable communication support in case of an emergency situation.
- The school has an up to date Asbestos Plan and complies with all District and State safety policies and expectations.
- During the school day all access gates are secured and visitors must enter through the main school office, sign the visitor log, and wear an identification badge while on the school grounds.
- For student safety and supervision before and after school hours the Extended Student Services (ESS) program is available to parents for our K-5 students.

The school district ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and replacing the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology. In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

XI. Instructional Planning and Scheduling

Professional Development

This section provides information on the number of days provided for professional development and continuous professional growth in the most recent three year period. Questions that may be answered include:

- What are the primary/major areas of focus for staff development and specifically how were they selected? For example, were student achievement data used to determine the need for professional development in reading instruction?
- What are the methods by which professional development is delivered (e.g., after school workshops, conference attendance, individual mentoring, etc.)?
- How are teachers supported during implementation (e.g., through in-class coaching, teacher-principal meetings, student performance data reporting, etc.)?

Research supports the positive effects professional development has on increasing student learning. All teaching staff is afforded the opportunity to participate in district and site sponsored professional development. These workshops are presented in a semester or year-long series and support a wide variety of professional development. These include the use of effective instructional strategies, implementing the use of computer technology in teaching and learning, critical reading, writing and mathematics strategies, effective use of assessments, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional development activities at the school, district, state, and national level. The Poway Professional Assistance Program (PPAP) provides support for new teachers. Teachers are encouraged to participate in the National Board Certification process and recognized by the Poway Unified School District when they earn NBCT status.
