### School Description and Mission Statement (School Year 2010-11)

This section provides information about the school, its programs and its goals.

Sunset Hills Elementary School, established in 1974, has a reputation for providing an excellent learning environment for students. Recognized by the State of California as a Distinguished School, Sunset Hills currently serves approximately 415 students in Kindergarten through Fifth grade. This quaint elementary school is located in Rancho Penasquitos and is part of the renowned Poway Unified School District (PUSD). Our school is proud of the rich diversity of cultural, ethnic, linguistic, and religious backgrounds of the community. The families of Sunset Hills represent more than 21 languages. Forty (44%) of our 415 students are non-anglo, with the largest racial group being Asian. Our current student population is 57% White, 15% Asian, 13% Hispanic, 12% Filipino, 4% African American, and 1% other. Approximately 55 of our students are currently receiving direct services or are being monitored through our ELL program. Fourteen percent (14%) of our students qualify for the Free and Reduced Lunch Program. Enhancing the schools diversity even more is the self-contained special education classes. Many of our Special Education Students are mainstreamed into the general education classes. This provides a valuable experience for all.

Sunset Hills has a long-standing reputation of providing an excellent learning environment. Visitors regularly comment about the friendly and welcoming environment of our school and the intense level of commitment every staff member has for each student's success. We wholeheartedly support our district's vision of " Rigor, Relevance and Relationships" to meet every child's need towards College Readiness. We believe that College Readiness means that we must prepare all students to have the skills to succeed after high school graduation. Character Counts lessons are embedded in many activities on campus including our TRRFFC Thursday assemblies where we come together to celebrate good character, friendship, our community and school pride. Each TRRFFC Thursday closes with our students, staff and parents enthusiastically pronouncing our Sunset Hills Seagull Chant: *"Sunset Hills is the Place to go. Setting goals is how we grow. Responsible is what we'll be. Fair, Caring and Trustworthy, Respectful Citizens, Respectful citizens of Sunset Hills. Seagulls!"*

Professional growth is a fundamental characteristic of the Sunset Hills's staff. We willingly share our expertise with focused collaborative activities. Many of our teachers have taken advantage of the district Teacher Learning Cooperative (TLC) as a means to grow professionally. During the 2011-2012 the site established a Leadership Team. The Leadership Team collaboratively lead and help facilitate school wide focus areas: Collaboration, Universal Achievement, Assessment/Goal Setting, and Technology. The staff is committed to continuous improvement in its quest of becoming a highly effective school.

The cornerstone of this educational parent community is the partnership of the Sunset Hills PTA and Foundation. Here at Sunset Hills we are lucky to have two parent-driven organizations that work collaboratively to ensure that our students have what they need to flourish and enjoy the very best elementary school experience. Our PTA strives each year to bring us programs that are academically enriching while the Sunset Hills Foundation works behind the scenes to fund essential academic resources. Our PTA sponsors programs like the Science Fair, Art Gala, Art Odyssey, Encore, transportation for field trips, Sock Hops, Talent Show and Running Club. Parents have many opportunities to assist at school such as classroom support, instructional support like Read Naturally and Morning Reads. Parents and community members volunteer in classrooms regularly, with more than 275 volunteers donating over 5000 hours last year. Our Foundation has raised funds for instructional supplies, Compass Learning, Computer Resource Specialist, and Impact Teachers to make differentiated learning a reality for ALL students.

The success of Sunset Hills owes much to the staff and parents, who give their time, share their skills and donate resources to our school. Our biggest strength at Sunset Hills is the sense of a caring community who work collaboratively on behalf of each and every student.

Annual training procedures and drills for earthquakes, lockdowns, and fire and bus evacuation are held. The district maintains a collaborative relationship with local law enforcement and the Office of Emergency Services to ensure optimal preparedness. Maintenance staff work with a scheduled preventive program to offset costly repairs at our older sites, whenever possible. The school has an up to date Asbestos Plan. Extended Student Services is available to students for before and after school childcare.

The school district ensures that students attend clean and safe facilities. The district's maintenance staff follows a comprehensive scheduled preventive and deferred maintenance program to offset costly repairs and minimize disruptions to the instructional program. A \$198 million school bond was passed by the community in 2002, which is funding the renovation of 23 older schools and replacing the oldest school in the district. Planned renovations at each school will address inequity of learning facilities, expand core facilities, add classrooms and improve access to technology. In accordance with Education Code Section 17070.75(e), the District uses a School Facilities Inspection System developed by the State of California to ensure that each of its schools is maintained in good repair. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. Daily cleaning schedules ensure that classrooms, offices and bathrooms are clean and well maintained. Playgrounds and fields are ample and well maintained. A full time custodian is on every campus throughout every school day. A night custodial crew cleans classrooms, restrooms and offices daily. The district has adopted cleaning standards for all schools. A summary of these standards is available at the district offices.

## IX. Student Performance

The Standardized Testing and Reporting (STAR) Program consists of several key components, including:

- California Standards Tests (CSTs), which include English-language arts (ELA) and mathematics in grades two through eleven; science in grades five, eight, and nine through eleven; and history-social science in grades eight, and nine through eleven.
- California Modified Assessment (CMA), an alternate assessment that is based on modified achievement standards in ELA for grades three through eleven; mathematics for grades three through seven, Algebra I, and Geometry; and science in grades five and eight, and Life Science in grade ten. The CMA is designed to assess those students whose disabilities preclude them from achieving grade-level proficiency on an assessment of the California content standards with or without accommodations.
- California Alternate Performance Assessment (CAPA), includes ELA and mathematics in grades two through eleven, and science for grades five, eight, and ten. The CAPA is given to those students with significant cognitive disabilities whose disabilities prevent them from taking either the CSTs with accommodations or modifications or the CMA with accommodations.

The assessments under the STAR Program show how well students are doing in relation to the state content standards. On each of these assessments, student scores are reported as performance levels.

## XI. Instructional Planning and Scheduling

### Professional Development

Research supports the positive effects professional development has on increasing student learning. All teaching staff is afforded the opportunity to participate in district and site sponsored professional development. These workshops are presented in a semester or year-long series and support a wide variety of professional development. These include the use of effective instructional strategies, implementing the use of computer technology in teaching and learning, critical reading, writing and mathematics strategies, effective use of assessments, positive discipline in-services, and multicultural training. Teachers and administrators are actively involved in professional development activities at the school, district, state, and national level. The Poway Professional Assistance Program (PPAP) provides support for new teachers. Teachers are encouraged to participate in the National Board Certification process and recognized by the Poway Unified School District when they earn NBCT status.
